2 27-11-2024 Heard the learned counsels for the parties.

2. Learned counsel for the Petitioner submits that Village-Torni was merged with Gram Panchayat-Sarsi Pipardaha, but the names of the petitioners, who are the residents of village-Torni, are not existing in the voter list of Sarsi Pipardaha PACS. He has further submitted that the representation of the petitioners is pending before the Block Cooperative Officer, Paliganj, and the District Cooperative Officer, Patna that was filed on 23-10-2024.

3. The Block Cooperative Officer, Paliganj and the District Cooperative Officer, Patna are directed to dispose of the representation of the petitioners within a period of four weeks.

4. With these observations, this writ petition stands disposed of.
