member of PACS in the year 2019 but his name is removed from the voter list in the year 2024 of Sonbarsha PACS, Block-Manjhi, Saran.

In that view of the matter, the petitioner may raise his grievance before the Registrar Co-operative Societies, Patna, Bihar, if the petitioner files his representation within a period of three weeks from today, the respondent no. 2 shall decide the matter within a period of twelve weeks from the date of filing of representation.
