2. Learned counsel for the petitioners Mr. Brisketu Sharan Pandey, Adv. submits that the client has taken no objection on 16.07.2024. But, from the record, it transpires that this case has been listed upon petition for urgent mentioning on 15.07.2024 by Mr. Brisketu Sharan Pandey, Adv. on record.

3. From the record, it transpires that the grievances of the petitioners are against East Central Railway through its General Manager, Vaishali at Hajipur. According to the Central Administrative Act and Rules, the remedy to the petitioners lies
