seeking the following relief:-

*"1. (i) For issuance of an appropriate
writ\ writs, order/ orders, direction/
directions in the nature of mandamus
directing the respondent no.3 to initiate*



the appropriate proceedings against the private respondents/Encroachers and decide the said proceedings to its logical conclusion within short span of time by removing the encroachment made by encroachers Private respondents over the Khata No. 894, Plot no.2894,2896,2901 and Khata No. 371, Plot No. 2852 and 2887 and Khata No. 671 Plot No. 2637 and 2890 area 6 Bigha, 6 Katha 14 Dhur situated in village- Bhawrajpur, Thana No. 290, Block- Aandar, District- Siwan.

(ii) For issuance of an appropriate writ/writs, order\orders, direction/directions in the nature of mandamus directing the respondent no.3 to decide the representation dated 10.11.2023 given by petitioner to him within short span of time in accordance with law."
