2. The petitioner has preferred the present contempt
petition against the Opposite Parties for violation of the order
dated 08.05.2023 passed in Cr. WJC No. 555 of 2023.

3. Learned counsel appearing for the contemnor



submits that the order dated 08.05.2023 passed in Cr. WJC No. 555 of 2023 has already been complied with as the District Magistrate, Bhagalpur has disposed the application filed by the petitioner under Section 97 of the CrPC on 18.06.2024 *vide* Annexure, OP-7/5.

4. Since the order dated 08.05.2023 passed in Cr. WJC No. 555 of 2023 has been complied with, we are not inclined to proceed further in the present matter against the Opposite Parties. The contempt petition stands dismissed.

5. However, petitioner is at liberty to challenge the order dated 18.06.2024 passed by District Magistrate, Bhagalpur before the appropriate forum in accordance with law.
