2 05-09-2024 After some argument, learned counsel for the petitioners submits that he is not pressing his prayer to set aside the impugned order dated 11.05.2023 passed by the learned Sub Judge-IX, Patna Sadar, Patna in Title Partition suit No. 456 of 1986 and confines his prayer to early disposal of Title Partition suit No. 456 of 1986 since the suit has been pending for almost 40 years.
