2. The present Modification Application has been filed seeking modification of the order dated 24.05.2023 in Cr. Misc. No. 6681 of 2023 on the ground that petitioner could not surrender within the time stipulated. The Court is taking a



consistent view not to extend the time of surrender in the event if the accused does not surrender within the time stipulated by the order by which Anticipatory bail was granted, as such the Court finds no merit in the Modification Application.
