of 2022), ix) Madhu Sudan Nandi (petitioner no. 169 of WPA 24632 of 2022), x) Sumita Mahato (petitioner no. 186 of WPA 24632 of 2022), xi) Paramita Roy (petitioner no. 199 of WPA 24632 of 2022), xii) Arpita Mondal (appellant no. 12 of CAN 1 of 2023), xiii) Md Asraful Alam Gazi (appellant no. 15 of CAN 1 of 2023), xiv) Sridhar Pramanik (appellant no. 79 of CAN 1 of 2023), xv) Sulekha Sur (appellant no. 103 of CAN 1 of 2023), xvi) Prasenjit Musib (appellant no. 154 of CAN 1 of 2023), xvii) Susovan Patra (appellant no. 165 of CAN 1 of 2023), xviii) Dipak Nag (appellant no. 166 of CAN 1 of 2023), xix) Chandan Pratihar (appellant no. 195 of CAN 1 of 2023) and xx) Tirthankar Ghosh (appellant no. 206 of CAN 1 of 2023)” failed to qualify themselves for the post of teacher conducted by the West Bengal Board of Primary Education.

Learned counsel prays leave to withdraw the writ petition along with all connected applications and with a prayer to allow the writ petitioners/applicants as mentioned above to file fresh writ petition.

Leave is granted.

Writ petition along with all connected applications are disposed of.
