ORDER:-

IN CIVIL APPLICATION NO. 715 OF 2023 :

1. Heard rival submissions. The learned Counsel Mr. R.C. Bora appearing on behalf of proposed legal representatives of respondent No. 7 namely 7A to 7F despite appearance, failed to file say. Moreover, he is also not present today.
2. The applicants are seeking permission to bring on record legal representatives of deceased respondent No.7 Syed Shaker Pasha s/o Syed Mehmood Quadri, who admittedly died on

21.02.2021, by condoning the delay of 597 days. Though the application is opposed, but considering the right to sue, the application is allowed in terms of prayer clauses (B) and (C) subject to cost of Rs. 1,000/- to be deposited with Library, Advocates Association of High Court, Bombay, Bench at Aurangabad within two weeks. Necessary amendment be carried out within stipulated period. Civil Application No. 715 of 2023 is accordingly disposed of.
