1. Heard the learned Advocates for the respective sides. The learned Advocate for the Petitioners submits that pursuant to the order of this Court dated 1<sup>st</sup> March, 2024, the District Deputy Registrar has tendered a report dated 14<sup>th</sup> March, 2024, to the office of the Minister for Co-operation and the Additional Secretary, Co-operation, Marketing and Textile, Government of Maharashtra, so also to the Director, Marketing, State of Maharashtra.
