1. Heard these applications at some length.
2. Learned Advocates for the parties including the learned APP has given the Court a fair background of the events in these proceedings. The record makes it clear that the several orders have been passed in these proceedings right from February 2023 onward and forward. The Applicants are protected by *ad-interim* orders, which are passed from time to time. The parties agree that these applications are required to be finally heard.
