PER COURT:

1. Civil Application Nos.3013 of 2024 and 3020 of 2024 for bringing the legal heirs on record are allowed and disposed of. The necessary amendment to be carried out within a period of two (02) weeks from today. The amounts to be disbursed thereafter.
