. We have heard learned Advocate Mr. A. D. Sonkawade holding

Advocate Mr. Shendurnikar for the applicant – intervenor in Civil  
Application No.2524 of 2024.

2. The learned Advocate for the petitioner seeks permission to add  
31 persons/employees, in respect of whom the prayer is made, as  
petitioners. The permission is granted. Amendment to add them as  
petitioners be carried out forthwith.

3. Learned Advocate for the petitioners to file Vakalatnama on behalf of added petitioners within a period of one week.

7. Affidavit-in-reply to be filed by the respondents positively on or before 13.03.2024, by giving a copy of the same to the other side in advance.
8. Learned AGP to call the record and ask the concerned officer to remain present on the next date.
9. Place the matter for further consideration on 15.03.2024.
