**ORDER**

1. Learned AGP Mr. P.S. Patil and representative officer for the appellant, Mr. Shekhar Khandu More, Nayeb Tahasildar, Sardar Sarovar Prakalp Karyalaya, Nandurbar, are present before Panel today.
2. The learned AGP on instructions seeks leave to withdraw first appeals in view of the Government Resolution No. Sankirna- 2014/ pra.kra.4/ Bham-1/A-4 dated 3<sup>rd</sup> November, 2016 with Government Corrigendum dated 23<sup>rd</sup> February, 2017 and 13<sup>th</sup> August, 2018 to the said Government Resolution.
3. Leave is granted. First appeals are disposed of as withdrawn.
4. If the amount is already deposited in this Court, the same shall be transmitted to the Reference Court. The respondents/Claimants shall be disbursed the amount with accrued interest thereon. If the amount is not deposited or if

there is deficit, the same shall be deposited before the Reference Court within a period of six months from today. The same shall be treated as an Undertaking. On deposit of such amount, same shall be disbursed to the respondents/ Claimants with accrued interest.

5. The court fees be refunded as per rules.
6. Award be drawn up accordingly.
7. Civil Application, if any, stands disposed of.
