PER COURT:

1. The admitted facts as they stand today, are that, a tower at the place earmarked has been erected. The tower was never to be erected in the land of the present Petitioner. In these circumstances, there is no hindrance for the project to proceed as per its plan.

5. The learned Advocate Shri. Gaikwad was requested to address the Court since he is on the Panel of the Electricity Transmission Company. He waives service and submits that, he would collect the copies of the Petition paper book and address the Court on the next date by taking instructions.
