**ORDER**  
**( 27<sup>th</sup> JULY, 2024 )**

1. These appeals are placed before today's National Lok Adalat by the appellant/State.

2. Today Mr. Mahesh Madhavrao Kulkarni, Dy. Executive Engineer, Sub Division Kukdi Project, is present on behalf of Collector, Latur alongwith AGP for Applicant/State before this National Lok Adalat.

3. The learned AGP for the appellant/State submits that the appeals are squarely covered by the Government Resolution No. Sankirna-2014/pra.kra.4/Bham-1/A-4 dated 3<sup>rd</sup> November, 2016 with Government Corrigendum dated 23<sup>rd</sup> February, 2017 and 13<sup>th</sup> August, 2018 to the said Government Resolution. The learned AGP further submits that the appeals can be withdrawn as per the policy decision taken by the Government of Maharashtra. Accordingly, the State is withdrawing these appeals. The statement made by learned AGP is accepted by both the parties in consonance with the recitals in the Government Resolution.

4. The learned AGP for the State further submits that entire amount in these appeals has been deposited in the Court and later on withdrawn by the original claimants by obtaining orders from the this Court. He further submits that, in these circumstances, nothing survives in these appeals.

5. It is clarified that, in case, any amount is lying with this Court, the office of this Court is directed to transmit the same to the reference Court.

6. The First Appeals stand disposed off as withdrawn.  
No order as to costs.

7. Consequently, pending Civil Applications, if any, shall also be disposed off. Delay if any, is condoned.

8. Award be drawn up accordingly.

9. The Court fee refund certificate be issued as per the provisions under the Maharashtra Court Fees Act.
