ORDER
(27th JULY, 2024)

1. These appeals are placed before today's National Lok Adalat by the appellant/State.
2. Today Mr. Gajanan S. Shinde, Tahsildar Deoni,

District Latur is present on behalf of Collector, Latur along with Additional AGP for the Appellant/State before the Panel of Lok Adalat.

3. The learned AGP for the appellant/State on instructions submits that the appeals are squarely covered by the Government Resolution No. Sankirna-2014/ pra.kra.4/ Bham-1/A-4 dated 3rd November, 2016 with Government Corrigendum dated 23rd February, 2017 and 13th August, 2018 to the said Government Resolution. The learned AGP further submits that the appeals can be withdrawn as per the policy decision taken by the Government of Maharashtra. Accordingly, the State is withdrawing these appeals. The statement made by learned AGP is accepted to both the parties in consonance with the recitals in the Government Resolution.

4. The learned AGP for the State further submits that entire amount in these appeals has been deposited in the Court and later on withdrawn by the original claimants by obtaining orders from the this Court. He further submits that, in these circumstances, nothing survives in these appeals.

5. In view of the above, the appeals are fit to be disposed off before this National Lok Adalat. However, before depositing off the appeals, it is clarified that, in case, any amount is lying with this Court, the office of this Court is directed to transmit the same to the reference Court. It is further clarified that, in case any amount is not deposited in the Court, the same shall be deposited in reference Court within a period of six months from the receipt of this order. The claimants are entitled to withdraw the deposited compensation amount alongwith accrued interest. The reference Court shall disburse the said amount alongwith accrued interest to the original claimants without requiring any formal application from them.

6. The First Appeals stand disposed off as withdrawn.
No order as to costs.

7. Consequently, pending Civil Applications, if any, shall also be disposed off.

8. Award be drawn up accordingly.

9. The Court fee refund certificate be issued as per the provisions under the Maharashtra Court Fees Act.
