1. Heard Mr. Hemant Kshirsagar, learned Advocate appearing for the applicants and Mr. Bhalerao, learned Advocate appearing for Acquiring Body. This is second application seeking withdrawal of amount by claimants.
2. Admittedly, applicants have withdrawn 50% of the amount deposited by respondent/Acquiring Body under order dated 19.07.2021. The present applications are moved for seeking withdrawal of the balance amount.
3. The learned Advocate appearing for the applicants submits that in some of the matters arising out of same acquisition, the claimants have withdrawn 100% awarded amount. Therefore, on the ground of parity, the applicants may also be permitted to withdraw balance amount.
4. Mr. Bhalerao, learned Advocate appearing for Acquiring Body submits that in some matters amount deposited in pursuance of Award with the Reference Court has been disbursed without notice to Acquiring Body. Thereafter, Appeals are also filed and pending.

5. Considering the submissions advanced, the applicants can be permitted to withdraw 25% amount in addition to the amount already withdrawn on furnishing usual undertaking. Rest of amount be kept in Fixed Deposit till disposal of the Appeals.

6. Civil Applications stand disposed of.
