2. The applicants have preferred first appeals against
the judgment and order/ award dated 16/12/2011, passed by
the Reference Court. Since there is delay of 06 days in filing
each appeal, these applications are preferred for condonation
of delay. The applicants have stated the reasons for the delay
in paragraph No.5 of the applications, which are as follows :-

“The applicants say that, they have forwarded the
