**CIVIL APPLICATIONS FOR CONDONATION OF DELAY**

01. Civil Applications are filed for condonation of delay of 1733 days caused in filing the appeals by the Acquiring Body. For the reasons stated in the applications, the applications for condonation of delay are allowed. The delay is condoned. The first appeals be registered.

(ii) Remaining amount shall be kept in fixed deposit in any nationalized bank, to be renewed from time to time till disposal of the appeal.

(iii) The civil applications stand disposed off.
