IN CIVIL APPLICATION NO. 5731 OF 2024 :

1. Heard rival submissions.
2. The applicant is seeking permission to bring on record legal representatives of deceased respondent No. 5 Mannumiya Inamdar, who admittedly died on 04.03.2021, by condoning the delay of only 1113 days. It appears that in other Civil Revision Application the legal representatives of aforesaid
