01. All these matters are arising out of acquisition proceedings

bearing No. LAQ/SR-No.47/04 acquired by S.L.A.O., Minor Irrigation Scheme Sur, Tal.. Jamner, Dist. Jalgaon. The parties have produced on record copy of order passed in Lokadalat dated 14.12.2019 in First Appeal No. 3614 of 2019 along with other connected appeals arising out of the same acquisition proceedings, wherein the appellant-acquiring body has accepted the award. The claimants have also accepted the award. All the parties have accepted the rate given by the learned Civil Judge, Senior Division, Jalgaon in LAR No. 323 of 2008. Cross-objections filed by the claimants have been disposed off. The order passed in First Appeal No.3614 of 2019 and connected matters in Lokadalat dated 14.12.2019 is taken on record and marked "X".
