1. Heard.
2. In Civil Applications No.8025 of 2024, 8024 of 2024, 8013 of 2024, 8020 of 2024 and 8046 of 2024, the learned counsel for the applicants submits that the legal heirs mentioned in the respective civil applications are the only legal heirs and that there are no other legal heirs. That, in some of the applications there is delay.
