PER COURT :

. This civil application has been moved by the Sansthan seeking permission for implementation of Resolution No.462 dated 03.07.2024 as regards acquisition of HIMS software at both the hospitals being run by the Sansthan and the requisite expenditure to be borne regarding maintenance.

2. The application is allowed. Permission is granted to implement the Resolution No.462 dated 03.07.2024 which in vernacular reads as under :

आवश्यक आहे की, यदा कदाचीत भविष्यात संस्थानने हे काम अन्य पुरवठाधारक कंपनीस दिले तर या पुरवठादाराने विनामुल्य सुलभरित्या त्या कंपनीस डेटा मायग्रेट करून द्यावा. सी.ए. दाखल करून मा.उच्च न्यायालयाची मान्यता घेण्यात यावी.
