PER COURT :-

1. In all these Applications, the common question arises that whether the delay which has been caused while lodging the appeals, can be condoned. Therefore, all these Applications are being heard together.

2. Having regard to the submissions canvassed on behalf of both the sides, I have gone through the record. The present Applicant is the Acquiring Body, has filed the present Applications and prayed for condonation of delay of 262, 263, 258, 262, 263, 258 days, respectively, caused while lodging the appeal against the judgment and award passed by the learned Joint Civil Judge, Senior Division, Kandhar.
