**ORDER**

1. Mr. Atul R. Kale, Additional Government Pleader and Mr. Anant Ajit Upadhye, Assistant Engineer Sina Project Canal, Sub-Division No.1, Shevgaon, District Ahmednagar, present.

Since the award of the learned Reference Court is less than four times of the award of the Land Acquisition Officer, the Government seeks leave to withdraw these appeals as per the Government Resolution No. Sankirna-2014/pra.kra.4/Bham-1/A-4, dated 3.11.2016 and subsequent Corrigendum, dated 23.02.2017 and 13.08.2018 to the said Government Resolution. Leave granted to withdraw.
3. All first appeals are disposed of as withdrawn.
5. Pending civil applications stand disposed of accordingly.
6. Respondent/claimants are entitled to withdraw the amount as per the Award, if not withdrawn.
