PER COURT :

1. Learned Advocate Ms. Sakshi Kale holding for learned Advocate Mr. Ajit Kale for the Applicants / Original Claimants submits that, the sisters of Deceased / Claimant No.1.14, namely, Vatsalabai Laxman Patil are personally present before the Court.
