**PER COURT :**

1. These applications are filed for condonation of delay of 2050 days caused in filing first appeals seeking enhancement of compensation.

2. Learned advocate for applicants states that in connected matters arising out of same acquisition, this Court has condoned the delay vide order dated 18/12/2019, passed in Civil Application No.9261/2019.

3. None appears for third respondent, though served. Learned AGP has strenuously opposed the applications stating that the delay is not properly explained and hence, the applications deserve to be rejected.

4. For the reasons stated in the applications, delay is condoned. Applications are allowed, on condition that applicants shall not be entitled for the interest for period of delay.
