PER COURT:

1. The learned Senior Advocates Shri. Pakale and Shri Bandiwadekar, along with the learned Advocates appearing for the respective Petitioners, submit that, after the Examination Council filed its affidavit-in-reply, the Petitioners have noticed two documents, one being the minutes of the meeting dated 11/05/2022, held by the Maharashtra State Examination Council, Pune, (Special Meeting No.3) and the order dated 10/06/2022, issued by the School Education and Sports Department, Mantralaya, Mumbai. In view of these documents, which have been placed on record along with the affidavit-in-reply by the Examination Council, some of the Petitioners pray for leave to amend. Shri. Pakhale, the learned Senior Advocate has showed a draft amendment in Writ Petition No.106/2023.

2. The learned A.G.Ps. submit that the Petitioners may take out Civil applications and seek leave to amend. The learned

Advocates for the Petitioners submit that, this will be time consuming. Instead, they submit that, since these Petitions are at pre-admission stage, leave to amend be granted and the Respondents be permitted to file additional affidavits-in-reply in a particular single case, so as to be adopted as a reply to the amended portion of the Writ Petition in all the cases.

3. In view of the above, we are permitting the parties to amend those matters, as may be desired. Let the amendment be carried out, on or before 20/09/2024. Thereafter, the Respondents are at liberty to enter their affidavits-in-reply, on or before 09/10/2024.

If any of the Petitioners desire that they wish to restrict their Petitions only to the extent of the proportionality of the punishment of de-barring them from appearing for the TET exam for life, they are at liberty to circulate their matters for early hearing.
