PER COURT :-

1. Heard the learned A.G.P. for the applicants.
2. Issue notice to respondents, returnable on 18.04.2024.
3. Learned A.G.P. submits that the learned Reference Court has enhanced the compensation exorbitantly compared to the assessment done by the Special Land Acquisition Officer. Considering the statement of the learned A.G.P., stay can be granted subject to condition of depositing the entire amount of the compensation as per the impugned awards.
4. There shall be stay to the impugned judgments and awards passed by the learned Reference Court till next date on the

condition to deposit the entire compensation as per impugned awards amount within ten weeks from today.

5. There shall be no extension of time to deposit the entire compensation amount in any event.

6. If the compensation amount is not deposited within the time granted, the stay would be vacated automatically.
