CIVIL APPLICATIONS FOR RESTORATION OF APPEALS

01. These applications are filed for restoration of respective appeals. The registration was refused by conditional order dated 06.05.2024 passed by the learned Registrar (Judicial) of this Court. In spite of orders, the appellants/applicants failed to take steps to remove office objections. It is reported that the office objection was in respect of filing of the Vakalatnama and same is now filed.

02. In view of above, the Civil Applications are allowed. The delay is condoned. The appeals are restored to their original position.

CIVIL APPLICATIONS FOR STAY

01. The learned Advocate for the applicant informs that the appellants-applicants have already deposited 50% of the amount as per the impugned judgment and award in the Reference Court. Remaining 50% amount is allowed to be deposited within 12 weeks from today in the office of this Court.
