1. Heard both the sides.
2. It is true that the Appellant – Maharashtra State Road Transport Corporation¹ has taken a defence of ‘*contributory negligence*’ of the driver of the scooter - claimant. The driver of the ST Bus has given evidence, so also, the injured. However, it does not find favour with the Tribunal.
3. There is an opposition on behalf of the Appellant – MSRTC for allowing the amount of compensation.
4. Considering the facts, following order is passed:-

ORDER

- (i) The Claimant is permitted to withdraw 60% of the deposited amount along with interest subject to furnishing an usual undertaking.
5. In view of that, **Interim Application stands disposed of.**
