1. Interim Application No.1347 of 2024 is not on Board.

2. On 28/02/2024, the Division Bench of this Court dismissed Interim Application No.3362 of 2023 for want of prosecution, by recording that the Applicant had not carried

out necessary amendment, thereby indicating that he was not interested in pursuing the application.
