1. The Appellant has filed motor accident claim petition bearing no. 413 of 1999 under Section 166 of the Motor Vehicles Act, 1988 before Motor Accident Claims Tribunal, Solapur (Ld. MACT) thereby claiming compensation of Rs. 1,00,000/- in respect of the injuries sustained by her in a motor vehicular accident dated 02.01.1998. The Ld. MACT had allowed the application and passed the judgment and award dated 21.01.2006, thereby directing the Respondents to jointly and severally pay compensation of Rs. 1,00,000/- with interest @ 7% from the date of application till realization.

2. That being aggrieved by the said judgment and award, the Appellant had preferred the aforesaid First Appeal which is pending before this Hon'ble High Court. That the Respondent

no. 2 Insurer has already deposited total amount of Rs. 1,51,183/- before the Ld. MACT, Solapur, towards satisfaction of the said judgment and award, which is the subject matter of the present appeal.

3. That during the pendency of the aforesaid Appeal, the Appellant and the Respondent no.2 had meetings for negotiations and settlement of dispute, wherein the parties have reached an amicable settlement between them. The Respondent no. 1 is Insured (formal party) and not a party to the present consent terms. The Appellant has agreed to accept an amount of Rs. 8,00,000/- (Rupees Eight Lacs Only) towards full and final settlement of their claim arising from the Award under challenge excluding an amount already paid.

4. The Respondent no. 2 shall deposit the said amount of Rs.8,00,000/- before the Ld. MACT, Solapur, within a period of four (4) weeks from the date of disposal of the First Appeal in view of the present Consent terms. The said amount, upon such deposit, shall be disbursed by the Ld. MACT, Solapur in favour of the Appellant.
