1. Both parties agree that Regular Civil Suit No. 145 of 2018 and Regular Civil Suit No. 852 of 2021 pending before Civil Judge Junior Division, Karad shall be decided together on its own merits without being influenced by any of the observations and findings recorded by the Trial Court as well as Appellate Court in its orders and the same shall be disposed of within a period of 6 months from the date of production of the order.

2. Both parties agree to maintain status quo in respect of their respective holdings in the suit property as on date until the determination of both the suits.

3. The Trial Court while deciding both Suits, shall take common evidence in both the suits which shall be part of both suits.

3. Parties shall be bound by the rights and obligations as stated in the Minutes of Order until determination of both the Suit proceedings which are directed to be heard together by the 5th Civil Judge Junior Division, Karad.

4. It is clarified that both the Suits shall be heard by 5th Civil Judge Junior Division Karad in view of the fact that at present both the Suits

are being heard separately by different Courts. Learned Civil Judge is requested to take common evidence in both the Suit proceedings and decide the same within a period of six months from today strictly in accordance with law. Parties shall co-operate with the learned Trial Court and not take any unnecessary adjournments unless absolute necessary.

6. In view of the above, Writ Petition Nos. 7340 of 2023, 7342 of 2023, 7346 of 2022 and 15189 of 2022 are disposed.
