2. Learned Counsel for the parties states that main relief sought for by the Petitioners is against the Education Institute which is common in all the Petitions. Learned counsels point out that substantive reply is filed by the education institute in Writ Petition No. 16776 of 2023 (Santosh s/o Ashok Devare & Ors. vs State of Maharashtra & Ors). Rejoinder is also filed.
