1. The clause 2 of operative part of the Impugned Order dated 06.05.2024 passed by the Ld. Trial Court stands modified to the extent that the Petitioner herein (Defendant in the nine suits) of i) Summary suit no. 640/2022, ii) Summary suit no. 625/2024 iii) Summary suit no. 628/2022, iv) Summary suit no. 626/2022, v) Summary suit no. 627/2022, vi)

Summary suit no. 630/2022, vii) Summary suit no. 631/2022, viii) Summary suit no. 624/2022, ix) Summary suit no. 629/2022) shall deposit a total sum of Rs. 15 Lakhs within four weeks from today, i.e., 28.08.2024, as conditional deposit for availing leave to defend. The Petitioner shall be allowed to file written statement within 30 days, thereafter. Rest of the operative part of order dated 06/05/2024 is unchanged.

2. The Trial of the nine suits is expedited and the Ld. Trial Court is hereby requested to complete the same expeditiously, preferably within a year.
3. The observations made by the Ld. Trial Court in its Impugned Order and the Petitioner's willingness to deposit the above amount shall not in any manner be construed as admission on part of the Petitioner to the suit claims and / or shall not affect, in any way, the proceedings before the Ld. Trial Court in the nine suits.
4. All the respective issues and contentions of the parties in the nine suits are kept open before the Ld. Trial Court.

5. Without prejudice to the rights and contentions of the parties.

6. The above Petition are hereby disposed of in terms of this order.
