1. Heard Mr. Rahul Shinde, learned Advocate for Applicants and Mr. Dilip Shinde, learned Advocate for Respondent.

2. At the outset, Mr. Rahul Shinde, learned Advocate for Applicants seek leave to amend the present Misc. Civil Application (for short “MCA”) as there is some error in the prayer clause. Leave to amend is granted. Necessary amendment shall be carried out within a period of one week from today. Re-verification stands dispensed with. It is clarified that on the next adjourned date, this Court shall not grant any further adjournment in this MCA.

5. Respondent is directed to take cognizance of this order and file Affidavit within a period of one week from today, if so desired.

6. On the next adjourned date, no grant whatsoever for any adjournment on behalf of the Respondent shall be considered by the Court which shall be noted by the Court in the presence of Mr. Dilip Shinde.

7. Stand over to **13th September 2024**.

8. In the meanwhile, ad-interim relief granted earlier, if any, shall continue.
