CONSENT TERMS

Amreen Farhaz Hudda i.e Wife and Farhaz Sulaiman Hudda i.e. Husband, adult
Indian Inhabitants do hereby state on solemn affirmation as under:-

1. The parties were married to each other on 22-12-2014.
2. They have one child, a girl named Zaira Farhaz Hudda born out of said wedlock now aged 5 years.
3. Due to certain disputes, both parties filed various legal proceedings against each other in courts in Mumbai and Nashik.

4. After due consideration and discussion in the mediation process directed by the Hon'ble Bombay High Court both parties have agreed to resolve their disputes and withdraw all cases filed against each other and continue to live together peacefully as husband and wife on the following terms and conditions.
- (a) The Husband i.e. Farhaz Hudda and Wife i.e. Amreen Hudda shall stay together in Nashik and continue their marital relationship with mutual love, respect, and understanding.
 - (b) The Husband undertakes to acquire an independent self-contained residential flat for himself, his wife and child to enable themselves to lead a happy and peaceful life in Nashik.
 - (c) The husband undertakes to dutifully maintain his wife and child at all times and bear all expenses related to his daughter Zaira's education, including school fees, tuition, extracurricular activities, and any other associated expenses as also maintain the new residential flat at his cost and expenses.
 - (d) The Husband undertakes to protect his Wife and treat her and his child with dignity and decorum and protect them from all forms of violence
Similarly, the wife will behave responsibly and respectfully towards the Husband and his family members with dignity and respect.
 - (e) Both parties have withdrawn all legal proceedings and complaints filed against each other and neither shall have any claim or demand against the other.
Both parties will cooperate in filing the necessary documents in the court to facilitate the withdrawal of cases.

(1) In case of any disputes arising out of this agreement, the parties agree to resolve them amicably.

(2) Both parties agree that their respective families will not interfere in their professional and marital lives and will respect their privacy.

(3) These consent terms are binding on both parties and their respective legal heirs.

(4) That the parties shall abide by the contents of the consent terms and comply with the same.

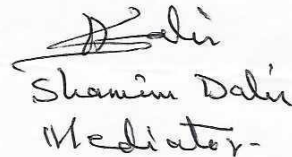
