Interim Application No.2521 of 2024 seek restoration of the Criminal Application (APL) No.1205 of 2017, which was disposed of in the wake of the statement made by the officer that the chargesheet shall be filed within the stipulated period.

In the wake of the aforesaid, the relief in the Application to restore the main Application No.1205 of 2017, do not require any consideration as the only change in the scenario today is belated filing of chargesheet.

Since on 25th April, 2024, the learned counsel for the Applicants sought instructions to withdraw the Application to file a discharge before the trial Court on filing of chargesheet, this remedy is still open to him pursuant to the chargesheet being filed.
