bearing Nos. A Sr. No.4632, Ledger No.43, A.R. No.8. Further relief is sought for Applicants be allowed to receive the amounts standing in the account in their names.

2. The present Interim Application being taken out in view of the letter received from the office of the Accounts Officer, High Court (O.S.), Bombay, being letter dated 23rd March, 2023 directing the Applicants to claim the unclaimed amount deposited in this Court by the Petitioner to the name of the Applicants as Beneficiaries.
