1. By the Administrative Order passed by the Hon'ble the Chief Justice, the Public Interest Litigation (L) No. 12834 of 2024 and Writ Petition No. 2144 of 2024 alongwith the Writ Petition No. 2703 of 2023, are placed before us for hearing.

We have taken note of the statement made by the learned Advocate General that the admission process shall be kept on hold till 18.07.2024.
