) the Hindu Succession Act, 1956. It is
) submitted that The Petitioner states that the
) parents of the Deceased pre-
) deceased the Deceased. The Petitioner
) further states that the husband of the
) Deceased, Mr. Yash Walayati Chopra pre-
) deceased the Deceased on October 2012 in
) Mumbai. Exhibit "C" to the petition is a
) photocopy of the death certificate of Mr.
) Yash Walayati Chopra, issued on 22nd

) November 2012. The Petitioner states that
) the Petitioner and Mr. Uday Yash Chopra are
) only sons of the Deceased from the wedlock
) with Mr. Yash Walayati Chopra. Therefore,
) the Deceased left, her two sons i.e. Mr. Uday
) Yash Chopra and Mr. Aditya Yash Chopra
) (being the Petitioner herein) as her only
) legal heirs and next of kin under the Hindu
) Succession Act, 1956, by which she was

) executor Uday Chopra has filed his affidavit
) dated 15th November 2023 relinquishing/
) renouncing his rights as executor. Consent
) Affidavit of son of the deceased as

) of Sanjeev Kohli, one of the attesting
) witness to the Will is filed. Affidavit of
) service of General Citation is filed. All
) affidavits are filed online. All other legal
) formalities are complied with. Hence,
) Petition is granted.
