This Application has been filed under the provisions of Section 11 of the Arbitration and Conciliation Act, 1996 (“the Act”), for appointment of an Arbitrator to arbitrate upon all disputes and differences arising between the parties under the Shipbuilding Contract dated 7th October, 2018 entered into between the parties for construction of one LED Display Barge.
