1. We have heard Mr. Kumar, learned counsel for the Applicant/revenue and Mr. P.C. Tripathi, learned counsel for the Respondent.

2. By this application, the applicant has prayed for condonation of delay of 174 days in filing the aforesaid appeal under the provisions of Section 260A of the Income Tax Act, 1961.

3. We have perused the averments as made in the application, which make out a sufficient case for the delay to be condoned. Also, there is no written opposition placed on record on behalf of the respondent to this Application, although an oral opposition.
