ORDER :

1. By this Indian Adoption Petition, the Petitioner and the Proposed Adoptive Parents have sought adoption of the male minor Ansh (“the said male minor”) born on 22nd February 2023. The

biological mother had surrendered the said male minor before the Child Welfare Committee, (CWC), Raigad, Maharashtra on 10th March 2023, and the said male minor was admitted to the Petitioner Institution on the same day as per order of CWC dated 10th March 2023. On 2nd June 2023 through its order, the said CWC, Raigad transferred the said male minor to CWC, Mumbai Suburban-I and the said male minor was admitted to the Petitioner institution on 6th June 2023. On 13th June 2023 through its order the CWC, Mumbai Suburban-I recognized that admission under the provisions of Juvenile Justice (Care and Protection of Children) Act, 2015 ("**the said Act**"). The admission order of the CWC is on record at page Nos. 21-22 to the Petition.

2. After making due inquiry under section 38 of the said Act the CWC, Mumbai Suburban-II declared the said male minor Ansh "Legally Free for Adoption" on 26th June 2023. The Free for adoption Certificate is on record at page Nos. 23-24 to the Petition.

3. The Prospective Adoptive Parents are Indian nationals, residing at Beed, Maharashtra, aged about 36 and 35 years respectively. They have been married for the past 9 years (01st December 2014) with no biological children.

4. The Motivation Letter from the Prospective Adoptive Parents is on record at page No. 32 to the Petition.
5. Affidavit by the Chief Functionary of the Specialized Adoption Agency (Petitioner) in support of the adoption of the said male minor is on record at page Nos. 163-168 to the Petition.
6. The Minutes of Adoption Committee Meeting held on 02nd February 2024 is on record at page No.20 to the Petition. It states that the Prospective Adoptive Parents are suitable to adopt the said male minor.
7. The Medical report dated 28th November 2023 of the Prospective Adoptive Parents state that they are mentally and physically fit to adopt a child. Their HIV I and HbsAg test reports certify the case as Non Reactive. These reports are on record at page Nos. 28-31 to the Petition.
8. The Prospective Adoptive Father is self-employed (Proprietor of Computech Solutions at Beed) since 2013 and his total income for the Assessment Year 20023-24 is Rs.4,96,770/-. His income Tax Returns are on record at page Nos.40-76 to the Petition.

9. The Prospective Adoptive Mother is self-employed (Proprietor of Sawariya Creations at Beed) since 2016 and her total income for the Assessment Year 2023-24 is Rs.4,93,400/-. Her Income Tax Returns are on record at page Nos. 77-90 to the Petition.

10. The copies of Pan Card, proof of residence and supportive financial documents are on record at page Nos. 77-90 to the Petition.

11. The childcare plan undertaking by the Prospective Adoptive Father's mother is on record at page Nos. 161-162 to the Petition.

12. The Home Study Report Part I: Self Assessment Reports by the Prospective Adoptive Parents is on record at page Nos. 93-100 and 118-131 to the Petition.

13. The Home Study Report Part II: Assessment Reports dated 16th July 2020 of the authorities of "Snehankur Adoption Center" Ahmednagar and updated report dated 10th January 2024 by the Specilalized Adoption Agency "Sulbha Suresh Joshi Shishugruh, Beed" have found the Prospective Adoptive Parents suitable for adopting a child. These reports are on record at page Nos. 101-117

and 132-140 to the Petition.

14. The child security undertaking dated 5th February 2024 of the Prospective Adoptive Father's cousin brother and sister-in-law residing at Aurangabad, Maharashtra to look after the said male minor in case of any mishap to the Prospective Adoptive Parents is on record at page Nos. 144-147 to the Petition.

15. The pre-adoption foster care undertaking dated 5th February 2024 is on record at page Nos. 38-39 to the Petition.

16. The Medical Examination Report of the said male minor dated 17st January 2024 states "Health status of the child: Normal. Overall observation of the child : Up to now, his overall development is within normal limits". The Prospective Adoptive Parents have countersigned the said report, which is on record at page Nos. 151-157 to the petition.

17. The HIV Report of the said male minor dated 23rd June 2023 certifies the case as Negative. This Report is on record at page No. 159 to the Petition. The photograph of the said male minor is on record at page 160 to the petition.

18. The Declaration of consent and undertaking by the Prospective Adoptive Parents state that they are willing to be appointed and declared as the Adoptive Parents of the said male minor. The said Declaration is on record at page Nos. 36-37 to the petition.

19. As regards the change of name, the Prospective Adoptive Parents desire that the said male minor “Ansh” be renamed as “Shivansh Nishant Ladda”.

20. The Undertaking dated 31st January 2024 given by the Specialized Adoption Agency “Sulbha Suresh Joshi Shishugruh, Beed” for furnishing post adoption follow-up reports is on record at page No. 171 to the petition.

21. The Petitioner institution’s recognition from the Women & Child Development, Maharashtra State to place children in adoption is valid for a period up to 05th July 2025.

22. Ms. Vandana Chinchkar, the Scrutiny Officer present at today’s hearing has tendered the Report of Mr. O. Hareendran, Scrutiny Officer of Indian Council of Social Welfare dated 4th September 2024, which is taken on record and marked “X” for

identification.

23. Having considered the material on record as well as the Report of Mr. O. Hareendran, Scrutiny Officer dated 4th September 2024, which is marked X, I am of the view that it would be in the interest of the said male minor child, that he is adopted by the Proposed Adopters.

24. It is relevant to note here that in the case of **Nisha Pradeep Pandya alias Nisha Amit Gor and Anr. Vs. Union of India and Ors.**,¹ concerning challenge raised to the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021, the Division Bench of this Court on 10th January, 2023 passed an interim order. The relevant portion of said order of Division Bench reads as follows :

“8. In the meantime, there will be an ad-interim order only until the next date in terms of prayer clauses (d), (e) and (f) of the petition which reads as follows:

(d) Pending the final hearing and disposal of the present Petition, the Hon’ble Court may be pleased to stay the effect, implementation and purport of the letter dated 30th September, 2022 issued by

Respondent No.2;

(e) Pending the final hearing and disposal of the present Petition, the Hon'ble Court may be pleased to direct the Respondents not to transfer pending adoption matters before the District Magistrates for adjudication.

(f) Pending the final hearing and disposal of the present Petition, the Hon'ble Court may be pleased to direct the Hon'ble Courts to continue with the adjudication of the adoption matters that are pending on their record and file.

9. Additionally, the safer and more prudent course of action would be to allow all matters to be placed before the learned Single Judge of this Court who is assigned those matters. Those orders may be continued to be passed until the challenge is finally decided.”

25. Hence, it is clear that this Court can consider and dispose of the present Petition.

26. In these circumstances, the Petition is allowed in terms of prayer clauses (a) to (d) of the Petition which read thus;

"(a) That the Prospective Adoptive Parents be given the said child in Adoption and be declared as parents and has all parental legal rights, Privileges and responsibilities over the said minor.

(b) That the Prospective Adoptive Parents may be granted leave to remove the said male minor from the jurisdiction of this Hon'ble Court and to take the said minor out of the jurisdiction of this Hon'ble Court whenever required.

(c) That the concerned Municipal Authority/Birth Certificate issuing Authority may be directed to issue Birth Certificate in the name of the said minor Shivansh Nishanth Ladda, born on 22nd February 2023 and stating that thereon that the Prospective Adoptive Parents as the Parents of the said minor.

(d) That the Prospective Adoptive Parents be allowed to change the name of the minor from Ansh to "Shivansh Nishant Ladda" born on 22/02/2023.

27. There is an undertaking of the Adoptive Parents in the Judge's order to invest a sum of Rs. 1,00,000/- in the name of Adopted Child. They also undertake not to withdraw this investment till the Adopted Child attains majority. They agree to hand over the

investment receipts to the Adopted Child on his becoming a major.

These undertakings are accepted as undertakings given to this Court.

28. The Judge's order is accepted and signed separately.

29. The Indian Adoption Petition is accordingly disposed of.

There shall be no order as to costs.
