2           Today when the matter is called out, Ms.Ganoo states that a  
further period of two weeks is required to file an affidavit because the same  
has to be affirmed at Delhi and thereafter brought here.

3           Acceding to her request, we now place this matter on 8<sup>th</sup> August,  
2024.

4           Since we have heard this matter substantially, both parties have  
requested us to keep this matter as part-heard. In view of the aforesaid  
request, we direct that in the event our present assignment changes, the  
parties are at liberty to move to the Hon'ble the Chief Justice (on the  
Administrative Side) to have the above matter assigned to this Bench.
