2. Mr. Mane, Advocate for the Petitioner submits that deceased left behind him last Will and Testament which was duly executed at Mumbai on 11.08.2021. The said Will is in Marathi language. Adv. for the Petitioner has filed affidavit dated 5th July 2024 for translation of the Will in English.

3. Mr. Mane, Advocate for the Petitioner submits that deceased was governed under the Hindu Succession Act, 1956. It is submitted that the Parents of the deceased predeceased the deceased. That the Wife of the deceased viz. Sarita Sadashiv Sawant,

) certificate of the wife of the deceased is not
) available with the Petitioner. That the
) deceased was survived by One Son and
) three Married Daughters only. That the

) next of kin left by the deceased.

) the attesting witness to the Will is filed.

) legal formalities are complied with. Hence,
) Petition is granted.
