submits that deceased left behind her last
Will and Testament which was duly
executed at Mumbai on 14.03.2020. The
said Will is in English language.

3. Mr. Ahmad, Advocate for the Petitioner
submits that deceased was governed under
the Hindu Succession Act, 1956. It is
submitted that the Parents of the deceased
predeceased the deceased. The deceased
died issueless. Deceased husband had one
brother and no sister. The brother of the
deceased died on 17.11.2021. The deceased
husband's brother Sukhdev Bhimrao Pawar

) had one son and had no daughter. Save and
) except as mentioned in para –8, there are no
) other legal heirs and next of kin left by the
) deceased. The Ld. Adv. for the Petitioner
) submits that the delay in making present
) Petition is on account of the fact that the
) Petitioner was ignorant and unaware of
) obtaining any legal representation. Now
) Petitioner has been advised to obtain a legal
) representation. Hence this Hon'ble Court in
) the interest of Justice may condone the
) delay. Thus, the delay is explained.

) Affidavit of nephew of the deceased as
) mentioned in para 8 is on record. Affidavit
) of Rakesh Bansilal Kanojia, one of the
) attesting witness to the Will is filed.
) Affidavit of service of General Citation is
) filed. All Affidavits are filed online. All other
) legal formalities are complied with. Hence,
) Petition is granted.
