Chitoor Ayyadurai Rajan, who died at Mumbai on 23.02.2013. Copy of death certificate is annexed at Exhibit- 'A' to the petition. Copy of Identification proof of deceased is already annexed at Exhibit- 'A1' to the petition.
2. Advocate for petitioner submits that deceased no. (2) viz. Rajam Rajan wd/o. Chitoor Ayyadurai Raj an, who died at Mumbai on 07.04.2017. Copy of death certificate is annexed at Exhibit- 'B' to the petition. Copy of Identification proof of deceased is already annexed at Exhibit- 'B1' to the petition.
3. Advocate for petitioner submits that both the said deceased resided at H/603, Gokul Residency Thakur Village, Kandivali (East), Mumbai- 400101 and/or left property within Greater Bombay and in the State of Maharashtra.
4. Advocate for petitioner submits that the legal heirs left behind the deceased surviving as his only heirs next-of-kin according to Hindu Succession Act, 1956 are mentioned in para no. 6 of the said petition.
5. Advocate for petitioner submits that both the said deceased died intestate and that due and diligent search has been made for Will but none has been found.

ORDER

- a. Office to Issue General Notice within two weeks from the date of uploading of this order.
- b. Advocate for the petitioner to file Affidavit of Service of General Notice and also effect service upon non-consenting legal heirs, if any as per Rules 399 and 400 of the Bombay High Court Original Side Rules and also justify surety of non-consenting legal heirs and furnish Administration Bond within one week thereafter.
- c. Office to verify if any cross petition is filed, if cross petition is filed, then take steps to place before the Hon'ble Court under Rule 407 of High Court Original Side Rules.
- d. List the matter on 10.07.2024 for compliance.
